Bill exchange can be submitted for redemption:

- maximum 5 working days prior to maturity date,
- till 12:00 on the maturity date,
- on one of the two working days immediately following the maturity date.

Enforcement draft can be submitted for redemption when:

- the obligation under enforcement draft matures,
- more than three years have not passed since maturity of the enforcement draft.
